#### MEETING CONVENED:

Mayor Price called the meeting to order and welcomed those in attendance. He explained that this was a special meeting to discuss and begin the annexation study process. He explained that the current meeting was not a public hearing and the Council would be deciding if they wanted to continue with a Resolution of Intent for the proposed annexation. He announced that there would be a public information meeting on June 19<sup>th</sup> and a public hearing held on June 30<sup>th</sup> to discuss annexation.

He then asked Mrs. Kelly Stultz, Director of Planning & Inspections, to come forward with her report.

Consideration of Annexation Study:

Mrs. Stultz explained that the Council and staff have discussed the process of considering potential annexation areas for more than a year. Each member of Council had received a copy of the study as presented. Today, they were asking for their review, approval or denial of the Resolution of Intent.

She explained that the Resolution of Intent was the first requirement of any annexation process. If the resolution was adopted today, the City Council may at any time between now and July 10, which would be the effective date of this annexation, further reduce the areas to be annexed or stop the process completely. If the resolution was not adopted, then the process stops now.

Annexation was an issue that raised much public concern. The North Carolina General Assembly made the decision to enact enabling legislation for annexation in 1959. Then and now, annexation is a part of the orderly growth of any municipality.

She noted that should the Council decide to proceed with the Glenn Farm area annexation, the developer for that area has expressed an interested in involuntary annexing the remaining two sections that he has of that subdivision. One was now underway with 53 additional lots and the other side had not been subdivided yet, but it was in similar in acreage. Additionally, once the infrastructure was across the river then annexing other residential areas on the west side of Highway 14 would increase revenues and help dilute the cost of the provision of infrastructure as it would be shared by more property.

There were always questions from citizens regarding plusses and minuses for annexation. There were issues about insurance about insurance service, organization rating of the various fire and inspection departments, water and sewer service, additional sanitation services, and all those things that were shared in their report.

As the Mayor had stated earlier, should this process continue, all of the residents of these areas would receive, by First Class mail a notice telling them what would happen at the various

meetings and what they need to do in order to prepare to present anything they would like to share with the Council. The public information meeting would be a lot more informal and would likely consist of staff with informational handouts and maps to answer questions. The public hearing would be when the Council would hear the most from residents of the various communities [involved].

To further clarify the dates, Mayor Price asked Mrs. Stultz to repeat the schedule.

Mrs. Stultz explained that the public information meeting would be June 19<sup>th</sup>, two days after the regular June City Council Meeting. The public hearing would be held on June 30<sup>th</sup> and that would require a July 10<sup>th</sup>, 2004 effective date for the annexation.

Council presented no questions or comments to Mrs. Stultz, therefore Mayor Price thanked her for her presentation.

Council Member Gover commented that after reviewing the packet he had tried to analyze what the city may encounter. He tried to look beyond the 6.2 years, he tried to look up to the 6.2 years, he looked at the money situation during the Water & Sewer Committee Meeting that was held earlier that day, knowing that they were in depressed times, and due to the enormous assessment fees that would be placed against their citizens as well as the money expected from the city to back that up, and the money that was needed for their existing water and sewer lines, he stated that he was not against the growth of their city, but he could not honestly sit there and vote for this annexation to begin.

He pointed out that it did not seem to be a good time to start taking on another major project such as this. He added that he still questioned what happened on Hopkins Court.

Council Member Epps commended the staff for their job. He noted that they talked about growth and how they would like to see their city go forward. He stated that he believed that this was a good program and he understood certain people's feelings about certain things, but he believed that could be resolved. He stated that he was in favor of this.

### RESOLUTION OF INTENT

A RESOLUTION STATING THE INTENT OF THE CITY OF EDEN TO CONSIDER ANNEXATION OF THE AREAS DESCRIBED HEREIN AND FIXING THE DATE OF PUBLIC INFORMATIONAL MEETING AND A PUBLIC HEARING ON THE QUESTION OF ANNEXATION

BE IT RESOLVED by the City Council of the City of Eden to consider annexation of the following described territories pursuant to Chapter 160A, Article 4A, Part 3 of the General Statutes of North Carolina:

#### AREA I – PARKDALE

Section 4. A report of plans for extending services to be above described territory shall be made available for public inspection at the office of the City Clerk at least thirty (30) days prior to the date of the public hearing.

Section 5. A legible map of the area to be annexed and a list of persons holding freehold interests in property in the area to be annexed who have been identified shall be posted in the Office of the City Clerk at least thirty (30) days before the date of the public hearing.

Section 6. Notice of the public informational meeting and public hearing shall be given by publication and by first class mail, as required by N.C.G.S. 160A-37.

Section 7. The effective date of the annexation shall be not less than one year following the date of adoption of the annexation ordinance.
