

Re: Expansion of Spray Historic District and Inclusion of Building Rehabilitation and Façade Grants


In 2005, former NC Main Street Director Rodney Swink travelled the streets of Eden as part of his city tour. He remarked that the Spray Traffic Circle area was "the money spot" meaning an area prime for development. Since 2017, Spray Cotton Mills has been purchased with a promise of mill rehabilitation into housing and business enterprises. The Spray Mercantile Building continues to host several community events, such as Grown and Gathered dinners, the Rubber Duck Regatta and Temptations in the Garden. Finally, a local entrepreneur has purchased the formerly dormant Garden Central building. He plans a microbrewery that will cater not just to adults but be family friendly as are many such establishments in Greensboro, Charlotte and Raleigh. They have activities that children and adults can enjoy.

Microbreweries are also often the catalyst for small town growth. They draw local and out of town patrons. The Millennial generation often seeks gathering places, especially those that have outside seating and are coupled with other amenities. The microbrewery is adjacent to both the Smith River Greenway and Island Ford Landing, providing many avenues for special activities. Area industry tells us they need entertainment venues to help attract younger workers who are actively seeing these amenities.

Because of the transformative nature of this type of business and the potential for tubing rental establishments, restaurants, and other outdoor-related businesses, a request is being made to consider two actions:

- Expand the Spray Historic District to encompass the area east of the Smith River traffic circle to include the former Garden Central facility.
- Expand the current building rehabilitation and façade grants to include this area. The building rehabilitation grant was designed to promote restaurant and other entertainment establishments. It has been effective in the downtown areas and could be put to good use in promoting development in this additional historic district. The façade grant will help with the building exterior.

These requests include no additional costs to the current approved budget but they will help incentivize additional transformative businesses. Please let us know if you have questions about these requests.

Re: City Council approval for Strategic Planning Commission projects

At its August 9, 2019 meeting, the Eden Strategic Planning Commission approved the following projects:

#### \$27,000 Dan River Nature Trail

This recommendation falls under Strategic Planning category REC-2 to expand and enhance trails, greenways and parks both as a health promotion and quality of place. The funding was approved by City Council for the 2018-19 budget year but Hurricane Michael damaged the trail and the project was put on hold. Public Works staff is restoring the trail area now, so it is logical to establish trail as it was originally planned. While \$27,000 is allocated, it most likely will cost far less to complete the project.

#### \$20,000 for Entrepreneurship Instruction

Economic Vitality 8 (EV8) seeks to promote the commercial areas as small business job centers. Entrepreneurship is a key to economic growth especially in the digital economy. Because the marketplace has changed so dramatically, infused by social media and ecommerce—elements that hardly existed fifteen years ago—aspiring and existing business owners need on-going assistance. The funding requested is for instructors and to begin a Service Corp for Retired Executives (SCORE) chapter in Eden.

#### \$15,000 for Upgrade of Tourism Web Site

Goal ED-4 is sharing information effectively and regularly with personal contact, using tools added with the Eden's 2016 web site and traditional methods. The current tourism site has not been updated in several years. Most people learn about a venue or community via a web site prior to visiting there. Recently, Cindy Adams took a trip to a NC Correctional Facility where women work 12-hour shifts answering questions about NC

Tourism. It is a unique way to help incarcerated women earn money and to help people learn more about NC. These women are the gateway to the state's tourist attractions for many out of state visitors. They rely on accurate and up to date web sites in order to provide the best information possible for their callers. The web site upgrade will help us achieve this goal. This investment will produce significant long-term benefits for Eden.

#### \$1,860 for Branding Storyboard to be displayed at Eden City Hall

Goal ED-3 called for the development and promotion of an Eden brand. The Branding process produced much useful information and recommendations. One of the most interesting items it offered was a synopsis of our community history and aspirations. A proposal is being made to create a storyboard with the branding narrative that will be placed on the wall of Eden City Hall. Both local citizens and visitors will learn more about Eden's history from this addition to Eden's most prominent public building.

#### \$5,000 for Spring 2020 Grown and Gathered Event

Strategy 2 of Economic Vitality included encouraging more outside dining opportunities. The Grown and Gathered events have sold out thus far as local residents and out of town visitors have eagerly participated. Originally one annual event was planned; the public response has necessitated two. These evens showcase local foods enjoyed at the picturesque Spray Mercantile facility. For those who question if Eden has enough going on, we urge them to attend one of these events to see our community at its finest.

#### \$12,500 for Otter Sculpture Public Art Project

The idea box for Goal EV-7 is developing a public arts plan. Several years ago, Dan E. Smith was named as Eden's otter mascot. That is because otters live along the banks of the Smith River. The next step in promoting this natural resource is to include an otter sculpture in the Spray traffic circle. A grant proposal has been submitted to establish an otter habitat along the Smith River, the first of its kind in the U.S. The otter sculpture will further reinforce Eden's natural resource branding and focus.

#### \$9,000 for Butterfly Trail at Smith River Greenway

The idea box for Goal EV-7 is developing a public arts plan. REC-2 involves expanding trails, greenways and parks. The 2019 Sunflower exhibit along the Smith River Greenway attracted many visitors interested in this addition to Eden's first nature trail. The butterfly exhibit will further enhance the greenway.

Total projects costs: \$90,360

Time is requested at the November Eden City Council meeting to present these projects and seek City Council approval so they can be completed.

#### **Eden Branding Statement**

The confluence of the Dan and Smith Rivers provided an ideal location for a center of commerce and industry. The Dan's navigation led to the historic community of Leaksville, established as market for trade between Virginia and North Carolina. Soon after, the industrious community of Spray was formed, harnessing the Smith River to power a manufacturing enterprise.

The railroad brought additional opportunity to the area, and the small town of Draper was developed as a thriving textile town a few miles to the east. From their humble beginnings, Leaksville, Spray and Draper each prospered in their own way, creating their own history, home town life and community. As time went by, each community had struggles and successes, ultimately realizing their symbiotic nature, but also the shared history and values that bound them together.

In 1967, the communities consolidated, advancing William Byrd's dream of self- sufficiency, community, and appreciation for the natural landscape that connects them. The collective community was named "Eden". The last fifty years has seen a changing economy, and for each lost industry, there is an equal and opposite success. The resiliency of the community has been on display with the resurgence of Karastan rugs, as well as the renewed commitment of UNC Rockingham Health Care.

While we continue to serve traditional economic development by providing jobs, commerce and water to the businesses at Berry Hill Industrial Park, our new economy is shaped by entrepreneurial energy, one that continues to rely on our natural environment. Today, Eden is a small town with unlimited access to the Great Outdoors. Once powering the textile mills along their banks, the two rivers now provide a natural experience second to none, whether it be paddling the Dan, floating the Smith, or simply enjoying a stroll along our greenways.

We are a base camp for the region, and our residents and visitors enjoy everything from hiking and mountain biking, hunting and fly fishing, as well as more passive exploration in parks and along trails. While Eden has changed over the past fifty years, we have remained the traditions that define the nature of our community:

- It's growing up "On" the Boulevard
- It's searching for a painted rock in Grogan Park
- It's the smell of burgers on the grill in the local diner
- It's sliding into home base at Freedom Park
- It's playing in the street until dark in Draper
- It's dressing up for Sunday service at the Rock Church
- It's renting a kayak and paddling the Smith
- It's our downtown champion small businesses, and their youthful entrepreneurial spirit
- It's learning both the science and art of craft brewing
- It's optimism in the face of adversity
- It's our hard working, proud, loyal mill town character
- It's our Vision that can only be described as Positively Eden.

#### <u>City Manager's Report – August 2019</u>

#### <u>Did You Know? – Financial Facts & Figures</u>

#### **General Fund**

The General Fund is the general operating fund of the City. The General Fund accounts for all financial resources except those that are required to be accounted for in another fund.

A review of the audited financial statements for the period ending June 30, 2018 reveals the fund balance in the General Fund increased from \$8,722,152 as of June 30, 2017 to \$9,408,745, an increase of \$686,593 or approximately 7.87%. According to the audited financial statements for the City of Eden, the total fund balance within the General Fund on June 30, 2000, was equal to \$4,157,472. This represents an increase of \$5,251,273 or 126.30% since that time.

The City Council voted back in 1998-99 to keep an unassigned fund balance, equal to at least three months operating expenses. As such, three months operating expenses would be \$4,149,183 according to the audited statements for the period ending June 30, 2018. The \$6,612,247 "unassigned" fund balance at June 30, 2018 is actually \$2,463,064 over that threshold. The unassigned fund balance in the General Fund as of June 30, 2000, was \$2,541,779. This is a total increase of \$4,070,468 or approximately 160.14% since that time.

When the audited financial statements for the period ending June 30, 2019 are completed, over the course of the next couple of months, it is anticipated that our fund balance in the General Fund will increase even higher from its level in 2018 based on a strong financial year during the most recent fiscal year.

Did you know that Eden continues to maintain the lowest tax rate in Rockingham County? In FY 2000-01 our tax rate was \$0.57 and today it is \$0.609. There has been **only one** tax increase in the last nineteen years and this includes any of the tax revaluations.

#### Water & Sewer Fund

The combined fund balance in the Water & Sewer Fund, the Mega Park Waterline Project Fund and the EPA Administrative Order of Consent (AOC) Sewer Project Fund for the period ending June 30, 2018 was \$7,099,131. This was a decrease of \$1,524,395 or approximately 17.68% when compared to the June 30, 2017 total of \$8,623,526. During the past seven years,

the lack of sufficient revenue has caused the City to use an extensive amount of its available fund balance. When you compare the June 30, 2018 figure of \$7,099,131 to the June 30, 2011 total of \$11,333,437 in available fund balance, it indicates the loss of \$4,234,306, or approximately 37.36% in just the past seven years. **However**, it should be noted that some of the fund balance funds used to "front" the engineering related costs associated with the EPA AOC since March 2017 will be reimbursed to the City once construction begins and the City is allowed to submit reimbursement requests thought the NC Connect Bond program. According to the audited financial statements for the City of Eden, the total fund balance within the Water & Sewer Fund on June 30, 2000, was equal to \$4,345,594. The June 30, 2018 fund balance of \$7,099,131 represents an increase of \$2,753,537 or 65.94% since that time despite the need to use so much fund balance over the course of the past seven years.

When the audited financial statements for the period ending June 30, 2019 are completed, over the course of the next couple of months, it is anticipated that our combined fund balance in the Water & Sewer Fund, the Mega Park Waterline Project Fund and the EPA Administrative Order of Consent (AOC) Sewer Project Fund will increase even higher from its level in 2018 based on a strong financial year during the most recent fiscal year.

Eden has made a substantial commitment towards the improvement and care of its infrastructure during the course of the past eighteen plus years. Since FY 2001-02, the City has spent approximately **\$59,627,909** on a variety of water and sewer infrastructure needs. Much of this spending was due to various unfunded mandates.

During the past six years, the City of Eden has been awarded <u>\$56,684,655</u> in grants and 0% or low interest loans for various water and sewer related projects that have already been completed, are currently underway, and will be completed over the course of the next few years. Of this total, \$28,309,039 or 49.94% is in the form of grants or principal forgiveness loans **that do not have to be repaid!** A special note of thanks to Mr. Terry Shelton, Director of Public Utilities and Mr. Mike Dougherty, Director of Economic Development. They have done a fantastic job at securing outside funding to meet many of our water and sewer related capital needs and do a tremendous job on a daily basis.

During just the next three years, we will be undertaking a significant amount of water and sewer infrastructure work. It is projected we will be spending more than \$\frac{\$40,000,000}{0}\$ in just the next three years for work associated with the EPA Administrative Order of Consent (AOC), the Mega Park Waterline Extension Project, and improvements at our Water Filtration Plant, Wastewater Treatment Plant as well as our distribution and collection system.

Did you know that despite all of the work that has been completed, there has been **NO** increase in our water and sewer rates since January 1, 2016?

#### **Personnel**

The current budget includes funding for 180 full-time positions. This is a reduction of one full-time position when compared to the FY 2018-19 budget. Included in this total are two COPs (Community Oriented Policing) Grant positions within the Police Department that the City Council authorized in late 2017. The 180 full-time positions represent a reduction of four full-time positions since October 2015. Without the two COPS Grant positions, the 180 full-time positions would have equaled a reduction of six full-time positions. During FY 1995-96, there were 203 full-time positions and during FY 2000-01, there were 189 full-time positions.

Did you know that for comparison purposes, Eden had a 2016 population of 15,279 and 14.05 square miles compared to Reidsville with a 2016 population of 14,152 and 13.68 square miles without Lake Reidsville? As noted previously, the current budget for the City of Eden includes funding for 180 full-time positions. According to information collected in February 2019, Reidsville was funding 193 full-time positions.

Our employees work hard, are often asked to wear multiple hats and are really a great group of individuals.

#### **Summary**

Over the past eighteen and a half years, we have worked diligently to improve the long-term financial condition of our City while continuing our commitment to offer a high level of service with less staff. The challenges moving forward, will be to develop a financial blueprint that will maintain the basic level of services the citizens have come to expect, a blueprint that maintains a strong fund balance for unanticipated needs and emergencies, a blueprint that will provide adequate funding in a timely fashion for a wide array of capital improvement and equipment replacement projects that are already facing the City and a blueprint that will retain employees and will continue to invest in the maintenance of employee skills, knowledge and abilities as a key community resource.

A contract to purchase the SGRTex facility was signed by a national company in July. The projected property settlement is mid-September.

#### KDH Defense Systems-New Military Contract

#### Bridge Street Road Repairs and Reopening

The road repairs and resurfacing on Bridge Street between Kings Highway and Highland Drive should be completed by Friday, August 23 weather permitting. The work is currently scheduled for Wednesday, August 14 if severe weather does not delay the project. The road should reopen within 24 hours after the completion of the work.

#### NCDOT Resurfacing

The paving crew contracted by NCDOT is still working on the resurfacing on US 29. The crew is scheduled to return to Eden once that job is completed.

#### Waterline Replacement Projects Update

After closing the southern section of West Avenue early on July 11, workers from Joyce Backhoe Service Inc. removed temporary stone from pavement cuts along West Avenue south of the intersection with Central Avenue. A steel plate was used to cover the cut in the middle of the street near that intersection while work progressed. A crew from Art Stanley Paving placed and compacted the asphalt binder after the stone base had been tamped by the Joyce Backhoe workers. The workers were able to complete the placement and compaction of the asphalt surface wearing course shortly before an afternoon rain event. Final payment on the West Avenue waterline replacement project was approved on July 24.


#### Fire Training Facility

The work to clear the land behind station 4 for the future fire training facility, has now been completed along with the necessary erosion control plan measures. The delivery of the building is scheduled for the second week in November. City staff will soon be completing the installation of a water line from Stadium Drive to the construction site and the setting of the hydrant.

The training facility will be two and half stories in height with two burn rooms. This will give us the ability to offer a wide variety of training scenarios ranging from fire attack to rescue operations along with ground ladder training and aerial truck operations. This new facility will provide more of a controlled environment, which will be safer for our firefighters and it will greatly enhance the training opportunities for years to come.

#### **Information Technology**

This month there are two cybersecurity bulletins everyone needs to be aware of. First, this weekend, news broke that Jeffrey Epstein was found dead in his cell from an apparent suicide. Internet criminals are going to exploit this celebrity death in a number of ways, so be careful with anything related to the Epstein death: emails, attachments, any social media (especially Facebook), texts on your phone, anything. There will be a number of scams related to this, so stay vigilant! Second, cybercriminals are now exploiting news of the Capital One breach to push a malicious backdoor trojan via a phishing email purporting to offer a Windows Security Update. See the example email below provided by security researchers at KnowBe4. Clicking the link in that email downloads a file named KB3085604.exe — obviously named to resemble Microsoft patch files and security updates. Detection of this file by the anti-malware engines represented on VirusTotal is poor, with only nine flagging it at this point.



The phishing email itself spoofs the targeted organization's IT department, and the language used is sufficiently informal (as well as a little technical and even awkward) to appear credible. IT departments will typically not ask you to install anything yourselves and especially not via email. Stop and think before you click!

#### **Municipal Services**

#### Pressure Washing Sidewalks

We are currently in the process of pressure washing all of the sidewalks in the Leaksville Downtown area. Once this has been completed our staff will move to the other downtown areas and then to sidewalks outside of our downtown areas. The work completed so far looks fantastic!

#### Repair of Storm Damage at 835 Bridge Street

The repairs to the culvert and surrounding areas that were damaged previously from storms at 835 Bridge Street have now been completed. Staff has completed all of the rough and final grading, which consisted of cutting ditches on both sides of the box culvert so that the storm water from the street can exit the road down to the culvert to the creek. We have also placed riprap in the ditch on the east side of the culvert for erosion control. The entire area has now been seeded and covered with straw. As noted previously, the road repairs and resurfacing on Bridge Street between Kings Highway and Highland Drive should be completed by August 23, weather permitting. According to estimates received by Mr. Paul Dishmon, Director of Municipal Services from Mr. Curtis Carroll of Old Castle Infrastructure, we were able to save more than one million dollars by doing this project in-house with city staff as opposed to contracting it out privately. Much thanks and appreciation to each employee that was involved with this project.

#### Parks & Recreation

#### Pod Casts with Mike Moore Media

Staff met recently with Mr. Mike Moore or Mike Moore Media to develop monthly pod casts to keep the Community informed about the offerings throughout the City related to Parks and Recreation. The first pod cast is currently scheduled for September 6, 2019.

#### Be Healthy Rockingham County

Staff continues to be involved with Be Healthy Rockingham County initiative. They attended the Be Healthy Rockingham County meeting on August 14 and will attend the September 11 meeting as well.

#### Splash Pad & Mill Avenue Swimming Pool

The Freedom Park Splash Pad will be open from 12:00 noon - 6:00 p.m. each day through September 15. Since our opening on June 26, there have been more than 11,000 visits to this facility. The Mill Avenue Pool will be open through the Labor Day weekend.

#### City of Eden Prowlers Football Program

#### **Planning & Inspections**

## **Code Enforcement**

114 notices have been mailed by certified mail and first class mail.

#### **Collections**

65 accounts were transferred to the Rockingham County Tax Department for collection of code enforcement fees due to the City of Eden. The amount transferred totaled \$86,091.47.

63 statements were mailed to property owners with an outstanding balance for code enforcement actions. Each property was researched through the Register of Deeds' on-line service to determine if any had been sold and letters were mailed to the new property owner advising them of the existing lien for code enforcement.

#### **Inspections**

Inspection volume has been normal for this time of year. We are expecting construction plans for Planet Fitness and Zip's Car Wash anytime now. The Burger King remodel is just about complete. The back wall of 620 Washington St. is currently under construction. This project should start to accelerate over the next couple of weeks.

We have completed 295 inspections in the past month. Additionally, we are covering the community with our proactive local code program daily. We have the city divided into 25 sections.

#### **Statute Changes**

The North Carolina General Assembly adopted a measure and it has been signed by the Governor on July 11 that creates a whole new Chapter in the Statutes that impact Local Planning and Development Regulation. It is entitled 160D. Much of 160A will cease to exist. The effective date of the new statutes is January 1, 2021. This means that before that date, every ordinance enforced by this department will have to be updated and changed to comply with the new rules. Staff intends to bring these changes to City Council over the next 17 months and have the changes be effective on January 1, 2021. Currently, we are going through the new provisions and matching them up with the existing ones to decide how to proceed with the revisions.

#### **Vacant Property Registration Ordinance**

The letters to owners of suspected vacant properties went out on July 23. Since then, there have been many telephone calls and office visits from owners asking questions about the new policy and registering the vacant properties.

#### **Boards and Commissions**

Our boards and commissions generally do not meet in July unless there are cases submitted by the public.

#### Historic Preservation Commission

The HPC met on August 12 and the main topic of discussion was concerns about the mural replacement on Washington Street. They plan to attend the August meeting of the City Council to share their views the City Council.

#### **Strategic Planning Commission**

The Strategic Planning Commission welcomed new members at their August 9 regular meeting. They received an annual report and a report for items for consideration for fiscal year 2019-2020. They have recommended several projects for Council's consideration at the August 2019 regular meeting.

#### **Stadium Drive Sidewalk**

We are currently seeking qualified professionals for the design phase of this project. We have spoken with several firms. The date for receipt of their response to our RFLOI (Request for Letters of Interest) is August 26. A staff committee has been created to review the Letters of Interest consisting of Kelly Stultz, Director of Planning and Inspections, Terry Shelton, Director of Public Utilities, Bev O'Dell, Director of Engineering and Paul Dishmon, Director of Municipal Services.

#### Grants

We currently have two grant applications submitted. The first one is the Historic Sub-Grant and the application for a CDBG housing and infrastructure grant in the Draper area was submitted on Friday July 12. The Pedestrian Planning Grant has also been submitted.

#### EPA AOC and Mandatory Projects to Stop Sewer System Overflows - Update

Construction on the Mebane Bridge digestion improvements project us now underway. This is the first of the remediation projects and opens the door for the city to begin drawing reimbursements from grant and loan funding for engineering work completed to date.

#### Southern Virginia Mega Site at Berry Hill

Haymes Brothers Inc. of Chatham, VA is currently delivering the pipe and other materials necessary to begin the installation of the City of Eden water line to the VA state line. This water line will provide most of the water to this industrial park and should be fully in place within the next 18-20 months.

Mayor Hall called the regular meeting of the Eden City Council to order and welcomed those in attendance. He explained that the Council met the third Tuesday of each month at 6 p.m. and worked from a prepared agenda; however, time would be set aside for business not on the printed agenda.

Pastor Mike McNamara of Draper Christian Church gave the invocation followed by the Pledge of Allegiance led by Fire Chief Tommy Underwood.

#### SET MEETING AGENDA:

#### PUBLIC HEARINGS:

There were no Public Hearings at this time.

#### REQUESTS AND PETITIONS OF CITIZENS:

Fran Peters, 313 S. Hundley Drive, had a couple of questions related to the Draper section of Eden. In the downtown Draper storefront area, there had been a few incidences with bulldozers knocking down buildings and there was one building with the back of it completely out. Anyone could get inside and she thought the floor was out of it as well. She would like to see something done about the building. She had also read in the minutes from the June City Council meeting about a grant to help the low- and moderate-income residents to the north and south of Stadium Drive. She said she was not certain exactly which streets would be included in the grant. A friend who lived in that area received a letter stating she would be visited on a certain day at a certain time but no one ever showed up. She would like to know what her friend should do to get evaluated for the grant. In reading last month's minutes, she thought another mural in Draper was approved. She wanted to know if there was a process to allow the residents of Draper to have a vote on what would be painted on the second mural.

Mayor Hall thanked Ms. Peters for her comments and concerns. He asked which building she had safety concerns about.

Ms. Peters said it was the third building in the downtown area. It was easily visible from the church.

Council Member Ellis said he knew the building she was concerned about.

Mayor Hall said they would do some further research on the building and if it was a safety issue it would be a priority. The grant proposal was being handled by the Director of Planning and Inspections Kelly Stultz. All they did at last month's meeting was agree to apply for grant funding. He did not think it was to the point of them offering any funding just yet. There may have been a letter sent out to residents to get some interest to use in the grant writing. He told Ms. Peters to have her friend reach out to Ms. Stultz. Mayor Hall asked Main Street Manager Randy Hunt to speak about the mural project.

Mr. Hunt said the mural on the side of A&B Pest Control was sponsored by the Eden Downtown Development Corporation and was vetted by their subcommittee for content. It sparked a lot of interest and many muralists had come forward but funding was an issue. They had a building in Draper in mind for the next mural but there was no plan in place for one immediately. There were plans to replace the mural on Washington Street at the Henry Street pocket park next. They hoped to have an official unveiling of the Draper mural later in the week.

Ms. Peters said the mural in Draper looked great and she had shared it as much as she could.

Local Codes Administrator/GIS Analyst Debra Madison told Ms. Peters to call the following day and she would be happy to explain about the letter and grant.

Ms. Madison replied the property was contiguous with the City limits just on the edge of Grand Oaks. The property owner had to drive through Grand Oaks to get to her property.

of Commerce, Get Fit Rockingham, and Eden Downtown Development Corporation. Their contact at NCDOT said it was very rare for a municipality to apply again the next year so he felt there could be a good chance Eden could get funding.

Mayor Hall said Eden's Pedestrian Plan had changed a lot over the last eight or nine years.

Ms. Madison replied the last plan was adopted in 2010. In order to apply for grants for improvements to sidewalks and walkability, a current plan was needed.

Council Member Burnette said the City did not have any biking areas and if the Pedestrian Plan could afford some of those, it would be great.

Council Member Grogan said particularly going toward Central Elementary School and the plans in that direction.

Ms. Madison replied the current plan requested the sidewalk in front of Central. They got that funding because it was identified as something needed. They were working on getting bids for that project.

A motion was made by Council Member Moore to adopt a Resolution in support of filing an application for Pedestrian Planning Grant Fund. Council Member Grogan seconded the motion. All members voted in favor of the motion. The motion carried.

#### **Engineering**

#### NCDOT Resurfacing:

APAC/Thompson Arthur is still working on the 2019 Rockingham Resurfacing schedule for the North Carolina Department of Transportation (NCDOT). Aiken Road, Summit Road and Landfall Drive have been resurfaced. Sections of Friendly Road, Northridge Drive, Wilshire Drive, Lincoln Street and Short Union Street are still on the schedule to be completed. The paving crew that was working in Eden was pulled off on June 27 to complete the resurfacing project on US 29. As of right now, the Project Manager does not know when they will be back in Eden.

The permanent pavement markings will be reinstalled when all of the resurfacing in the Eden area has been completed.

# Waterline Replacement Projects Update

Hydrostatic pressure testing of the new water main installed along West Avenue by Joyce Backhoe Service Inc. was passed on June 12 without any issues. Chlorination and other testing procedures continued through June 18. The last replacement water tap and tie-over to the new water main was completed on June 26. The crew returned three days later to temporarily shut off the water to customers, then cut and abandon the old 2-inch diameter galvanized water main. A paving subcontractor is scheduled to be on site July 11 to place asphalt material in the pavement cuts.

A small crew from Citty's Plumbing and Pools, Inc. worked on punch list items for the Jackson Street and W. Moore Street waterline replacement project on the first day of July. Additional dirt, grass seed, fertilizer and straw was placed at several locations along the disturbed shoulder

areas. The crew was also able to remove a silt basin and repair the ditch line where it had been located.

A crew from Citty's Plumbing and Pools, Inc. returned to the Ridge Avenue waterline replacement project on June 19 and was able to cut and cap the old 2-inch diameter galvanized water main at the intersection of N. Hale Street. The crew returned two days later to remove temporary stone from two pavement cuts, then place and tamp asphalt to complete work on the project.

# **Municipal Services**

#### Solid Waste Ordinance Provisions

According to the Solid Waste ordinance 12-56, Yard Rubbish, Tires and Trash:

- A. Trees, sections of tree trunks, tree stumps and tree limbs larger than those described in 12-57 (C) will not be collected by the city, and shall be removed from the premises by the owner.
- B. The city will not remove yard rubbish or trash from a vacant lot without the payment of appropriate fees.
- C. Tires will not be collected by the city, and shall be removed from the premises by the owner.
- D. Wooden pallets, discarded computer equipment and discarded televisions will not be collected by the city, and shall be removed from the premises by the owner.

According to the Solid Waste ordinance 12-57, Preparation for collection:

- A. Fine accumulations shall be placed for pickup at the curb but not in the street, and shall contain no rocks, masonry, and the like.
- B. Yard rubbish and trash, other than that described in subsection (C) and 12-58, shall be removed by the owner by placing it at curbside for pickup on established days. The collection schedule shall be kept on file in the Office of the City Clerk.
- C. Trees, sections of tree trunk, tree and shrubbery limbs placed at curbside for collection shall be no larger than the following:
  - a. Zero to four inches in diameter, maximum six-feet long;
  - b. Four to eight inches in diameter, maximum two-feet long.
- D. Loose-leaf collection shall be provided throughout the year. In order to be collected, leaves shall be raked to a point behind the curb where pickup will be made. Leaves and yard waste placed in plastic bags or other containers will not be picked up.

#### **Parks & Recreation Information**

Due to the Community Accents and Parks & Recreation radio programs with WLOE not being conducted any longer, staff is working with Mike Moore of Mike Moore Media to develop monthly pod casts to help keep the community informed about Parks and Recreation activities happening throughout the City. More information will be released once it is available – stay tuned!

#### Be Healthy Rockingham County

Staff continues to be involved with Be Healthy Rockingham County initiative. They attended the Be Healthy Rockingham County meeting on July 10 and will attend the August 14 meeting as well.

#### Freedom Park Splash Pad

The Freedom Park Splash Pad was opened to the public on June 26. The ribbon cutting for this facility was held on July 9 with over 200 people in attendance. During the first 13 days the facility has been open, there has been over 3,700 visits. We are very proud of this facility and hope each of you will have an opportunity to come by for a cool splash!

The putt-putt golf course at Freedom Park is available to the public Monday – Sunday from 4:00 p.m. – 8:00 p.m. The cost is \$2.00 per round.

#### Matrimony Creek Nature Trail - Phase II

Construction of Phase II of the Matrimony Creek Nature Trail is currently underway and should be completed by the end of August.

#### **Planning & Inspections**

#### Code Enforcement

A total of 236 notices have been mailed by certified and first class mail that affect the following number of properties: 99 for high grass, 6 for high grass, junk storage and disabled vehicles, 1 for high grass and a zoning violation, 24 for junk storage, 10 for zoning violations, 4 for junk storage and disabled vehicles, 22 for disabled vehicles, 1 for a collapsed carport, 1 for yard waste accumulation, 1 for sewage discharge into yard, 13 for violation of Human Habitation Standards and 1 for violation of the Non-Residential Building Maintenance Standards.

For fiscal year 2018-2019 we have transferred \$86,091.47 to the Rockingham County Tax Department for collection with ad valorem taxes.

#### Historic Walking Tour Brochure

Work has now been completed on the Historic Walking Tour Brochure and the Brochures have been printed.

#### Community Appearance Commission

The commission purchased small flags for national patriotic celebrations. Mr. Michael Hutchinson, a volunteer member of the commission put out more than 100 of these flags at various city installations and public spaces for the 4th of July Holiday.

### CDBG Housing and Infrastructure Grant

The application for the CDBG (Community Development Block Grant) Grant will be submitted by July 11. Both the consultant and staff have taken applications from numerous homeowner's in the proposed target area. The consultant has told us that the people in the area have been welcoming and have made information easily available for the grant submission. We sent out letters in advance of the applications being taken to nearly 250 households in the target area.

#### Stadium Drive Sidewalk

We have been given permission to hire an engineering and design firm on this project. This request will be sent out this month.

#### Vacant Downtown Buildings Ordinance

This ordinance was adopted in May of 2019. Staff has surveyed the areas denoted in the ordinance and letters are being prepared to go out to the various property owners. They will go out on Friday July 19.

#### North Carolina General Statutes Changes

For a few years, there have been discussions at the State level concerning an overhaul of the statutes in Article 19 of chapter 160A pertaining to cities and Article 18 of Chapter 153A pertaining to counties. This is the first major overhaul since 1973. As of January 1, 2021 both of the chapters will be repealed and the new Chapter 160D will take its place. This gives us 1.5 years to change every statute reference in our various land use ordinances and to change the regulations in them to meet the new requirements. The UNC School Government has indicated that it will be holding workshops on the changes.

#### Police

#### Stand Against Litter

The Eden Police Department continues to ask citizens to Stand Against Litter as part of the countywide campaign to aggressively enforce littering and illegal dumping violations. Be advised that we are aggressively enforcing littering and illegal dumping statutes.

#### Public Utilities

# EPA AOC and Mandatory Projects to Stop Sewer System Overflows - Update

We are on schedule for our projects and our documentation submittals to the EPA and NC Water Infrastructure. The Mebane Bridge digestion improvements project has received all of the necessary approvals and the contractor is beginning construction of this project. The remaining projects of the remediation plan will bid in sequence between now and September. All projects in the remediation plan should be approved and ready to begin by January 1, 2020.

#### Southern Virginia Mega Site at Berry Hill

Haymes Brothers Inc. of Chatham, VA won the bid to install the City of Eden water line to the VA state line. They were the lowest of the three firms who bid on the project. This line will provide most of the water to this industrial park. The bid was roughly \$1.5 million under the engineering firm estimate for the construction portion of this project. Haymes Brothers is currently extending the City of Eden sewer line from the VA state line to the Mega Park. We have issued the official notice to proceed and construction is expected to take about 18 months to complete.

#### b. Our State campaign update.

Mayor Hall called on Coordinator of Tourism & Special Events/Projects Cindy Adams.

Ms. Adams thanked the Council and Strategic Planning Commission for believing in her projects and approving funding. The Our State Digital Package was recently completed. It included a video and an accompanying article that would live on the Our State Magazine website for 12 months. She thanked Laurie Wilson and Mark Bishopric, perfect spokespersons for the video. She presented them two-year subscriptions to Our State Magazine. The article covered so much more than just the video by including The Barn, shops downtown, Freedom Park, the splash pad, RiverFest and more. Between the article and video, it covered all of the charming things in Eden. She thanked all of the citizens who participated in the video. She thanked Director of Economic Development Mike Dougherty for corralling all of the people for the video while she set up for Grown and Gathered.

- Our State Magazine.com metrics showed 2,384 pages with an average time spent of 4 minutes and 29 seconds, which meant the people watched the entire video
- Our State email blasts had 43,678 recipients that saw the article and video.

That was pretty incredible numbers for just two weeks. She added it up and it was a total of 292,151 reaches. It was a great value.

Council Member Grogan asked Ms. Adams if they were sharing the stats on Facebook and in the media.

Ms. Adams replied that she had just gotten the stats but she would share those on Facebook and other social media.

The Our State video and newest Did You Know video were played for the Council and audience.

Ms. Adams said there were 10 or 15 Did You Know videos running all of the time on WGSR TV. These videos were just a few seconds long and teased the viewers to go to the website to see what Eden offered. She had put a packet with information about all of the things happening in Eden at each Council Member's chair:

- Shaggin' on Fieldcrest would be on Saturday, July 20
- Karastan Rug Mosaic Unveiling on Monday, August 12
- Grown & Gathered would be Thursday, August 15
- Touch-A-Truck would be Saturday, August 24
- Riverfest will follow on September 20 and 21

Another Strategic Planning project was a new brochure which was a great accompaniment to the Our State Magazine video and article. The brochure would be placed across the area and State. She expected a big crowd for the mosaic unveiling as people from all over the County were interested in the project. The Karastan Rug Mosaic was also another Strategic Planning Commission project. There was a new supply of the I Love Eden T-shirts. After Hoke Flynt and his family went to the Grand Canyon and posted a picture wearing the shirts, people started asking where they could purchase them. The shirts were available for \$10 each. Within the next 10 days, the sunflowers should bloom on the Smith River Greenway. Sunflower flags would be placed at each end of the trail for people to know the sunflowers were in bloom. A beautiful metal sign had been placed that said Smith River Greenway Sunflower Field Eden, NC for people to take pictures in front of the flowers. Ten educational trivia signs about sunflowers were placed along the fields to make it fun for kids.


Mayor Hall congratulated Ms. Adams and her department on the excellent quality video. He personally ran into people from Hillsborough and from Carrboro who were visiting because they saw the video.

#### **CONSENT AGENDA:**

- a. Approval and adoption of the June 18, 2019.
- b. Approval of a traffic study recommendation and adoption of an Ordinance regulating the speed limit on Von Ruck Road.

Sgt. Jim Robertson wrote in a memo on May 19, 2019 that Chief Greg Light received a traffic study request about Von Ruck Road from Council Member Burnette. Von Ruck Road was in a residential area and had approximately 14 households along it. As with all residential areas, the chances for pedestrian traffic were heightened, particularly children. An order was issued for speed surveys to be completed on Von Ruck Road. Speed data was collected from 50 vehicles traveling through the area. The data showed that 63% of the recorded traffic was traveling at or below 25mph. Another 30% of traffic was traveling between 26mph to 30mph. Due to the residential nature of the area and the data showing the sample vehicles self-conforming to a 25mph speed limit, the recommendation of the Police Department was that the speed limit on Von Ruck Road be reduced to 25mph.

# AN ORDINANCE REDUCING THE SPEED LIMIT ON VON RUCK ROAD FROM W. MEADOW ROAD NORTHWARD TO FARRELL STREET

BE IT ORDAINED BY THE CITY COUNCIL of the City of Eden, North Carolina, pursuant to authority granted by N.C.G.S. § 20-141(e) that:

Section 1 – The City Council of the City of Eden has determined that operation of a motor vehicle Thirty-Five (35) miles per hour on Von Ruck Road from W. Meadow Road northward to Farrell Street is greater than is reasonable and safe under the conditions existing upon Von Ruck Road from W. Meadow Road northward to Farrell Street.

Section 2 – It shall be an infraction to operate a motor vehicle on Von Ruck Road from W. Meadow Road northward to Farrell Street in excess of Twenty-Five (25) miles per hour.

Section 3 – Signs shall be placed, erected or installed on each side of Von Ruck Road from W. Meadow Road northward to Farrell Street giving notice of the speed limit to traffic traveling in each direction on said road.

Section 4 – The OFFICIAL TRAFFIC MAP of the City of Eden is hereby amended to conform with this Ordinance.

Section 5 – All ordinances in conflict with this Ordinance are hereby repealed.

c. Adoption of a Reimbursement Resolution in the General Fund for the Emergency Services Fire Training Facility Project.

Director of Finance and Personnel Tammie McMichael wrote in a memo the 19-20 Budget included a 5-year loan for \$466,400 for the Emergency Services Fire Training Facility. The reimbursement resolution is in place so that if we use any General Fund-Fund Balance to pay for the expenditures we will be able to reimburse the General Fund-Fund Balance with the loan proceeds when the city does an installment purchase.

RESOLUTION OF THE CITY OF EDEN, NORTH CAROLINA DECLARING THE INTENT OF THE CITY TO REIMBURSE ITSELF FOR CAPITAL EXPENDITURES INCURRED IN CONNECTION WITH THE EMERGENCY SERVICES FIRE TRAINING FACILITY FROM THE PROCEEDS OF CERTAIN TAX-EXEMPT OBLIGATIONS TO BE EXECUTED AND DELIVERED IN THE FISCAL YEAR 2019-2020.

WHEREAS, the Eden City Council (the "Council") has determined that it is in the best interests of the City to finance the construction, renovation, and improvements of a certain project within the City known as the (1) Emergency Services Fire Training Facility (the "Project"); and

WHEREAS, the City presently intends, at one time or from time to time, to finance all of a portion of the costs of the Project with proceeds of tax-exempt obligations and reasonably expects to execute and deliver its tax-exempt obligations (the "Obligations") to finance, or to reimburse itself for, all or a portion of the costs of the Project; and

WHEREAS, the City desires to proceed with the Project and will incur and pay certain expenditures in connection with the Project prior to the date of execution and delivery of the Obligations (the "Original Expenditures"), such Original Expenditures to be paid for originally from a source other than the proceeds of the Obligations, and the City intends, and reasonably expects, to reimburse its General Fund for such Original Expenditures from a portion of the proceeds of the Obligations to be executed and delivered at a date occurring after the dates of such Original Expenditures.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Eden City Council as follows:

Section 1. Official Declaration of Intent. The City presently intends, and reasonably expects, to reimburse its General Fund for the Original Expenditures incurred and paid on or after the date occurring 60 days prior to the date of adoption of this resolution from a portion of the proceeds of the Obligations. The City reasonably expects to execute and deliver the Obligations in the Fiscal Year 2019-2020 to finance all of a portion of the costs of the Project and the maximum principal amount of Obligations expected to be executed and delivered by the City to pay for all or a portion of the costs of the Project, which amount is subject to change, is expected to be \$466,400.00.

Section 2. Compliance with Regulations. The City adopts this Resolution as a declaration of official intent under Section 1.150-2 of the Treasury Regulation promulgated under Section 103 of the Internal Revenue Code of 1986, as amended, to evidence the City's intent to reimburse its General Fund for the Original Expenditures from proceeds of the Obligations.

Section 3. Itemization of Capital Expenditures. The Director of Finance for the City, with advice from the City Attorney, is hereby authorized, directed and designated to act on behalf of the City in determining and itemizing all of the Original Expenditures incurred and paid by the City in connection with the Project during the period commencing on the date occurring 60 days prior to the date of adoption of this Resolution and ending on the date of execution and delivery of the Obligations.

Section 4. Effective Date. This Resolution is effective immediately on the date of its adoption.

Ballistic vest manufacturers put a limited warranty on vests sold to law enforcement. The industry standard is a five year warranty. This means we must replace each officer's ballistic vest every five years so the officer is covered by the vest manufacturer's warranty. In May of 2019, several of our officers' vests came due for replacement. We currently have twenty five surplus vests in our inventory that we cannot issue due to being expired. The Rockingham County Community College Basic Law Enforcement Training Director, Jim Gunn, has requested help with obtaining old ballistic vests to use in the BLET program at RCC. Director Gunn requires each participating BLET student wear a ballistic vest throughout their BLET training. This helps prepare students to enter the career of law enforcement. Most agencies today have a mandatory wear policy and require, at a minimum, each officer participating in a patrol or risk duty wear a ballistic vest. The BLET program is not obtaining these vests with the intent of using them for their ballistic capability, but rather a training aid to help students adjust to the added weight and restrictions wearing a ballistic vest puts on an individual. Director Gunn has relayed to me that the current vests the BLET program is using are several years old and in dire need of replacement. We do not have a good avenue for disposal of these vests and we feel this is an ideal situation to dispose of this surplus property and help our partners at Rockingham Community College.

#### Release

The Rockingham County Community College Basic Law Enforcement Training program (RCC BLET) understands and agrees that the City of Eden and the City of Eden Police Department (City), by Resolution dated August 20, 2019, are donating to it twenty five (25) KDH Defense, Inc. ballistic vests that were manufactured from 2013 to 2014.

The RCC BLET program understands that the manufacturer's standard expected life of a ballistic vest is five (5) years, and that these vests have outlived their manufacturer's warranty. The RCC BLET program also understands that the City of Eden in no way guarantees the quality, fitness of purpose or effectiveness of these vests, and in no way does the City of Eden endorse this type or brand of vest.
