FACILITY RULES & REGULATIONS

5. The person to whom this permit has been issued shall be liable for any damage, loss of injury sustained by any person by reason of negligence on behalf of the person or group receiving this permit.
6. The Director or his representative shall have the authority to revoke this permit upon finding a violation of department rules and regulations or City Ordinance.
