- 7. The proposed activity will not entail unusual, extraordinary or burdensome expense or require police services by the City of Eden.
- 8. Parking permitted only in designated areas.
- 9. Fees must be paid before use of field.
- 10. Absolutely NO games may begin after 11pm.

Effect of Permit: The person seeking this permit shall be bound by all Parks and Recreation Department Facility rules and regulationS and all applicable City Ordinances.
