#### MEETING CONVENED:

Mayor Tuggle called the regular meeting of the Eden City Council to order and welcomed those in attendance. He explained that the Council meets the third Tuesday of each month at 7:30 p.m. and works from a prepared agenda; however, time would be set aside for business not on the printed agenda.

#### **INVOCATION:**

Mr. Wayne Parleir, Pastor of Meadow View United Methodist Church, gave the invocation followed by the Pledge of Allegiance.

#### PROCLAMATIONS:

Mayor Tuggle asked Ms. Lori Lowrimore and Ms. Wanda Stophel to come forward. He then read the following proclamation:

#### **PROCLAMATION**

#### **Remember Me Thursday**

Mayor Tuggle asked Ms. Debbie Ellis, Laquista Knox, Shay Graham, Susan Arrington, and Teresa Lowe, representatives from the North Carolina Department of Health and Human Services to come forward. He then read the following proclamation:

#### SET MEETING AGENDA:

Mayor Tuggle noted that Council Member Darryl Carter was absent from the meeting.

Mayor Tuggle stated that there was a request by staff to remove item 9b - Authorization to proceed with the purchase of a ladder truck from Unfinished Business.

A motion was made by Council Member Ellis seconded by Council Member Hampton to remove item 9b - authorization to proceed with the purchase of a ladder truck from Unfinished Business and also to set the meeting agenda.

All Council Members present voted in favor of this motion. This motion carried.

#### **PUBLIC HEARINGS:**

There were no public hearings scheduled at this time.

#### REQUESTS AND PETITIONS OF CITIZENS:

Mr. Davis Montgomery, District Manager of Duke Energy Addressed the City Council:

Mr. Montgomery explained that they have been doing demolition on the Dan River plant as they have been decommissioning it. He wanted to make them aware of a few things that would be happening over the next couple of weeks.

- 1. Elevated tank that supplied water to the old plant would be taken down. It will be very simple, they would take the legs out from under it and pull it over. He added that this would occur during the daytime hours.
- 2. As they repair the new water intake on the river, they will have to dredge mud and silt from behind the flood gates and that would occur over the next few weeks.
- 3. He also explained that they have a "Employee Volunteer Event" that would take place in Eden on October 3. Mr. Johnny Farmer has been very instrumental in helping them identify projects around town. They placed this on their employee portal and over 100 people signed up to work. He thanked Mr. Farmer for his help with that.

Council Member Burnette questioned where the dredging material would go.

Mr. Montgomery replied that it would be stored on site but eventually that building will come down so there may be some of that used as fill.

\*\*\*\*\*

Ms. Erlene Tinsley, 1236 Forest Road, Addressed the City Council:

Ms. Tinsley explained that she had a problem with her water bill. Her water bill has gone up 50%. She came to City Hall and talked to someone about two weeks ago they sent someone out to read her meter. She came back to City Hall and talked to them again and they said that it was right. They sent someone out to read the meter again and they found no leak anywhere. They sent someone out and then they sent a letter listing how many gallons of water she had used a day.

She explained that she was hospitalized for four (4) days at Duke. On those days while she was in the hospital they had her using 379, 155, 167 and 688 gallons of water a day while she was in the hospital. She stated that she did not understand it so she got a plumber to come in and he found no leaks anywhere.

She stated that this was a problem for her as to why her water bill has increased. She pointed out that she was also on a feeding tube so therefore she did not cook and she did not go in the kitchen. She did not use water as far as washing dishes or cooking so she could not understand this. She asked what could be done.

Mayor Tuggle referred to the City Manager and asked if he could contact Ms. Tinsley and meet with her.

Mr. Corcoran asked for a phone number to set up an appointment.

\*\*\*\*\*

Roger and Teresa Hodge, 624 Fisher Street, Addressed the City Council:

Mr. Hodge explained that he came to the meeting in November of last year and complained about drainage and that he was not getting the city services that his tax dollars was supposed to be paying for. He pointed out that things have not changed a bit, it was unsafe.

Mayor Tuggle asked that he reiterate to the Council what the services were.

Mr. Hodge explained that he came down here and complained that above his house on Fisher Street the grass, not just one blade of it but the whole road was covered, for 2½' to 3' and that makes the road more narrow and they (cars) will crowd you real bad going through there. He also complained that the ditches were unsafe because they do not have an apron and he had seen people fall in the ditch trying to get out of the way of the cars

because there was no apron there. He had also asked for guttering, not curbing, but just for gutter to put the pipes in. He got very little service because they did not even come down there and mow his ditches right beside his house. He explained that his house sits approximately well not as far as the corner of that thing right there (*pointed to something in the room*) from the road and he had weeds over there and he figured last year when he made the complaint to them that the city would maybe step up to the bat and start taking care of the ditch. He added that you cannot hardly back out of the driveway because you cannot see to back out or pull out of the driveway, the weeds were so high.

Mrs. Hodge added that they have had a person stop and ask them if they were trying to conceal their house because you could not see it and they live real close to the road. She also added that when she backed back out of her driveway she had to look around the weeds because they were as high as that ceiling there to which Mr. Hodge pointed out that it was not quite that high.

Mr. Hodge stated that it was a public safety. It was their safety backing out into that road and the ditches without aprons on them they were a public safety. Like he had said, there were people coming up through there and when they step out of the way of a car they fall into the ditch.

He stated that he had a drainage problem that goes back to January 18, 2005 where he had complained about the bottom of the road, not at his house but at the bottom of the road, there was a curb and there were two pipes. One runs out of the driveway and there was one that runs under the road. They were 15" pipes and there was an extremely large amount of water that comes down that hill and when it rains real hard the whole road covers over. That was another safety hazard there plus when those pipes run over, he owned the house at the bottom of the hill too, and when they run over, they flood the basement down there. He stated that he needed Mr. Corcoran or somebody, one of the City Council or all of them to come out to his house and let him show them what else he had.

Mr. Corcoran commented that he would pull it tomorrow and he asked the City Council to remember that when Mr. Hodge was there in November, he had not seen Mr. Hodge since. He had not come in to talk to him or call. He added that Ms. Tammy Amos, Engineering, did a quite an extensive report on this situation after he appeared before the Council and that report was shared with each of them. This was an ongoing problem and there was a long history if he remembered correctly of Mr. Hodge and Engineering and these issues so he would be glad to meet with Mr. Hodge anytime if he wants to come in. He added that he believed he said that in November and in the meantime he would get Ms. Amos's report and share that with everyone and they could go from there.

Mayor Tuggle questioned the location of Fisher Street to which Mr. Hodge explained that it was directly across from the Salvation Army. Mayor Tuggle asked Mr. and Mrs. Hodge to call Mr. Corcoran.

He also offered to go to the Hodge's house himself to take a look at it. He stated that usually when someone comes in there without seeing it for himself, he could tell them directly, both sides of it. He stated that they would look and see if there was some of the things could work out.

Mrs. Hodge stated that they own three houses on that road and it was a poor community and they were trying their best to get their road straightened out and to look halfway decent.

Mayor Tuggle stated that was why he wanted to come to their house so he could see for himself but of course he could take the city's side as well as their side on things but maybe they could find a compromise. He asked Mr. and Mrs. Hodge to contact the City Manager so they could come in and talk with him.

Mr. Hodge noted in the letter he had just received from Ms. Amos, she said she could inform the City Council that he (Mr. Hodge) was getting all the services. He was not getting the services.

Mayor Tuggle stated that was what they would sit down and talk about and he would tell him exactly how he felt about it.

Mr. Hodge replied that he knew how he was going to feel about it, all he had to do was see it.

Mayor Tuggle replied that he would see it and he was just a straight shooter. He would tell Mr. Hodge exactly how he felt about it one way or another. If the city needs to do something then he would talk about that and if part of it was on the Hodge's he would tell them.

Mr. Hodge commented that he had one more thing to say, if it was on him he would pay it, well he had several things marked here but he would try to cut it as short as possible. Anyhow they were talking about the storm water drainage program and what Ms. Amos had to say about it was she told him that the storm drainage had been established but he did not seem interested because it would be partially at his expense. He stated that he would tell them all something. He put 160' of corrugated black pipe at \$184 a piece there...

Mayor Tuggle stated that he could show him all that.

Mr. Hodge replied that it did not matter because he had fixed it and he did not need their storm drainage.

Mayor Tuggle explained that he would do his homework first before he came out there as he wanted to make sure he got all that done so it would probably be next week.

Mr. Hodge closed by stating that after this meeting it looked like the city would come out there and mow the ditches.

#### **UNFINISHED BUSINESS:**

a. Consideration of Amended Interlocal Agreement to Provide Consolidated 911 Service within Rockingham County.

Mayor Tuggle asked the City Attorney, Ms. Erin Gilley, to explain the request.

Based upon direction from Municipal and County officials, Bob Shaver, County attorney, and I have drafted an amendment to the Interlocal Agreement for the Consolidation of 911 Service within Rockingham County.

This amendment, if enacted, would shift the funding obligations of the center and services to the County. In addition, as of January 1, 2016, oversight of the agency will be transitioned from the Governance Board to the County with advisory support from the Governance Advisory Board. The Governance Advisory Board will retain its authority concerning talk group assignments and CAD/RMS upgrades.

This Agreement must be approved by all municipalities and the County to be enacted.

Ms. Gilley's recommendation to Council is that the Amended Interlocal Agreement to Provide Consolidated 911 Service within Rockingham County be adopted.

Mayor Tuggle added that if they would recall this was something that they were spending about \$38,000 a year that they would not have to pay anymore.

A motion was made by Council Member Epps seconded by Council Member Ellis to approve this amended agreement.

Council Member Hall questioned the signatures required on the document and that if passed tonight was it still contingent on the other municipalities signing on it as well and have any of them done anything yet

Ms. Gilley replied that it was.

Mr. Corcoran added that everybody has adopted it or has it on their next meeting to adopt it.

Ms. Gilley also added that if it is not approved by one it will not be effective and they would still be operating under the original agreement.

Council Member Burnette stated that he knew they were very instrumental in this and asked the Mayor that as far as he could tell was everything to his satisfaction to which Mayor Tuggle replied that as far as he could tell, everything has worked out well.

Action on the motion was as follows: Council Members Hampton, Burnette, Ellis, Hall, Turner and Epps voted in favor of this motion. This motion carried.

Ms. Valencia Roner, Program Manager, Duke Energy, gave the following presentation:





Council Member Burnette pointed out that the energy conservation program has been around a pretty good while and he thought it was important to explain why energy conservation is important to Duke Energy.

Mr. Montgomery explained that there were several reasons but if you look at it from a load perspective if they can shave some of the energy usage off of that peak it makes it more economical for them and for their customers. It means they do not have to crank up an extra generator just to meet that one brief moment during the cold winter months. For the customers themselves, it helps them save energy on their bills and they know that there are other things that a customer is able to spend their money on these days. If a customer is unable to pay their bill, it does not benefit either one of them so they were trying to help them manage their bill as well.

Ms. Roner added that the other part of this was education. They really want the customer to take an active role. They would provide basic information in the form of a pamphlet and it explains things like the importance of changing air filters or if you have air leaks, that can get sealed up, or keep your door closed.

Mayor Tuggle thanked them for their presentation.

Council Member Ellis questioned why they had only selected certain sections in Draper.

Ms. Roner explained that they were only allowed an estimate of about 1,000 so prior to even beginning the program they use the U.S. Census data to help them determine which areas to go to.

#### REPORTS FROM STAFF:

There were no reports at this time.

#### **CONSENT AGENDA:**

- a. Approval and Adoption of Minutes: August 19, 2014.
- b. Traffic Study Request in reference to changing the speed limit on Greenwood Street.

A traffic study was received from Council Member Jim Burnette in reference to changing the speed limit on Greenwood Street. The speed limit on Greenwood Street is currently 35 MPH. Greenwood Street is primarily a residential area approximately six blocks in length with a number of streets intersecting, leading from both residential and business sections of the City.

Due to the length of Greenwood Street, it was determined that a survey in reference to the proposed speed limit change should be sent to each of the property owners (70 in number) along Greenwood Street. A survey was prepared and sent to each of the property owners. 18.57% (13 of 70) responded. 92.31% (12 of 13) of the respondents were in favor of

reducing the speed limit to 25 MPH. Only 7.69% (1 of 13) of the respondents were in favor of keeping the current 35 MPH speed limit.

Of the respondents in favor of reducing the speed limit to 25 MPH, three mentioned a concern for the safety of children living in the area, one mentioned a concern for the pedestrians in the area, and six mentioned general concerns dealing with speeding and safety.

A visual survey of posted speed limits in the area shows that Oak Street, Irving Avenue, Glovenia Street, Moir Street, and Manley Street are posted 25 MPH and that The Boulevard is posted 20 MPH.

The Police Department's recommendation is that the speed limit for the entire length of Greenwood Street be reduced to 25 MPH.
