# PROCLAMATIONS:

## FALL LITTER SWEEP PROCLAMATION

#### **PROCLAMATION**

## NATIONAL ADOPT A SHELTER DOG MONTH

WHEREAS, shelter dogs hold a special place in the hearts of all animal lovers, and

**WHEREAS**, approximately 8 to 10 million companion animals enter animal shelters nationwide every year, and approximately 3 to 4 million are euthanized, and

WHEREAS, most times animals were given up due to the owner's irresponsibility or lack of initiative. In a recent study by the National Council on Pet Population and Policy the top reason people surrender their dogs to shelters are due to behavioral problems followed by housing situations, incompatibility with the family's lifestyle, and finally because the dog didn't live up to the owner's expectations, and

**WHEREAS,** all shelter dogs need a loving owner and a safe, happy home. Many shelter adoptees even say that shelter pets know that their new owners saved them and therefore have a special bond with their new parents.

Shelter Dog Fast Facts According to AnimalShelter.org

- 8-10 million dogs and cats enter shelters each year
- 3-4 million dogs and cats euthanized by shelters each year
- 3-4 million dogs and cats adopted from shelters each year
- 4.000-6.000 animal shelters in the U.S.
- 25% of purebred dogs are in shelters
- A female dog and her offspring can produce 67,000 dogs in six years
- Between 600,000 and 750,000 dogs and cats reclaimed by owners each year from animal shelters

**NOW, THEREFORE, I WAYNE R. #### CITY OF EDEN PROCLAMATION

WHEREAS, the City of Eden is committed to ensuring the safety and security of all those living in and visiting our city; and

**WHEREAS**, fire is a serious public safety concern both locally and nationally, and homes are the locations where people are at greatest risk from fire; and

**WHEREAS**, home fires killed more than 2,380 people in the United States in 2012, according to the National Fire Protection Association (NFPA); and

**WHEREAS**, the kitchen is the leading area of origin for home fires and most kitchen fires are caused by cooking. On average, there are roughly 3,000 reported kitchen fires per day in the United States; and

**WHEREAS**, Eden residents should stay in the kitchen when frying food on the stovetop, keep a three-foot kid-free zone around cooking areas and keep anything that can catch fire away from stove tops; and

**WHEREAS**, residents who have planned and practiced a home fire escape plan are more prepared and will therefore be more likely to survive a fire; and

WHEREAS, working smoke alarms cut the risk of dying in reported home fires in half; and

**WHEREAS**, the City of Eden's first responders are dedicated to reducing the occurrence of home fires and home fire injuries through prevention and protection education; and

**WHEREAS**, the City of Eden's residents are responsive to public education measures and are able to take personal steps to increase their safety from fire, especially in their homes; and

**WHEREAS**, the 2013 Fire Prevention Week theme, "Prevent Kitchen Fires!" effectively serves to remind us to stay alert and use caution when cooking to reduce the risk of kitchen fires.

**THEREFORE, I WAYNE R. TUGGLE, SR., Mayor Pro Tem of the City of Eden** do hereby proclaim October 6-12, 2013, as Fire Prevention Week throughout this city, and encourage all citizens of Eden to check their kitchens for fire hazards and use safe cooking practices during Fire Prevention Week 2013, and to support the many public safety activities and efforts of the City of Eden's fire and emergency services.

# REQUESTS AND PETITIONS OF CITIZENS:

Ms. Jean Ann Wood, 237 Ray Street addressed Council:

Ms. Wood explained that she wanted provide an update on Get Fit Eden. During the months of June, July and August participants were encouraged to be active 3 times a week for at least 30 minutes each time. Tracking the activity and submitting a completed tracking card earned them the opportunity to enter a grand prize drawing. Registration for the program commenced at the May City Council meeting. Presently over 400 people registered and participants received a Get Fit Eden t-shirt, compliments of Gildan Activewear and other sponsors. To feel success weekly community walks were held at the Garden of Eden Senior Center and Smith River Greenway and additionally at Freedom Park in June and then they moved to Old Leaksville and Draper Village for July and August. Walks were hosted by City officials, chamber and community volunteers. Also, Carla Huffman set up a rotating schedule providing opportunities to try it before you buy it at local fitness centers and yoga studios.

Some of the success stories include: Elaine, the first to turn in her completed card. She was excited that she might win. She also noted she was already a winner because of the program. Shirley is 70 years old and has lost 90 pounds following Weight Watchers healthy living program. She recently testified at their Weight Watchers meeting that she had not made an exercise commitment until Get Fit Eden encouraged her to set the activity goal of 3 times a week. The activity boosted her summer weight loss and has allowed her to tackle a big hill in her neighborhood.

Tony and Kim were walking regularly and experienced weight loss and through the Get Fit Eden program they spurred their weight loss, tried out the YMCA and then decided to join and become regular members.

Donna has struggled with several chronic illnesses and in her career she cares for others and has put her health on the back burner. So her doctor gave her the okay to participate and in addition to losing 30 pounds this summer, she enjoyed the free week at the YMCA that rekindled an old love for swimming so she joined the Y and she loves the water aerobics program.

Hope is a young professional in the community who was not reaching her physical activity potential. Through Get Fit Eden she set summer goals, encouraged other family members to walk with her, and joined Cross-Fit. She has led community walks and wants to help the future of the program.

She also read a letter from another citizen who appreciated the program.

Ms. Wood expressed a thank you to the City of Eden for partnership and a thank you to Mayor Pro Tem Tuggle for his commitment to the program. She also thanked Mr. Mike Dougherty for ideas and logistics. In closing, she also thanked the following businesses

and individuals for financial and in-kind support: Gildan, Eden Drug, Wayne Tuggle, Donna Turner, Jim Burnette, Brad Corcoran, Mike Dougherty, Deanna Hunt, Carla Huffman, Eden Parks & Recreation Department, Torie Goric, Ellen Hutchins, Dee Moyer, Pete Crouch, Lynn Dyer, Teresa Lee, Kelly Pulliam and to the owners and staff of the Eden YMCA, Body Fit, Fast-Fit and Cross-Fit.

Right now they are in the process of collecting those activity cards and will have the drawing for the I-Pad at Riverfest this Friday.

# **UNFINISHED BUSINESS:**

There was no unfinished business scheduled.

# **NEW BUSINESS:**

a. Recommendation to accept bid on 1291 South Avenue.

Ms. Stultz explained that the city has received a bid on the vacant lot located at 1291 South Avenue in the amount of \$1,000.00 from Deborah Chambers. The tax value of the property is \$6,270.00.

The advertisement for bids was run in the Eden Daily News on August 4 and August 7, 2013. The advertisement for upset bids was run in the Eden Daily news on August 21, 2013. No upset bids were received.

The house situated on the lot was demolished by the City of Eden as a result of a housing code violation and the lot was purchased by the City at public auction through the collection process. The amounts paid out for the demolition was \$2,700.00.

In addition to the demolition cost, we advertised for bids. The property is being sold subject to unpaid property taxes. The amount due as of August 31, 2013, is \$1,234.05.

In her opinion, their best outcome is to sell the property, regain what they can and encourage new development on the site.

Council Member Burnette asked and they have had this property for three years correct to which Ms. Stultz replied in the affirmative and added that the person will have to pay the taxes. Council Member Burnette stated that he thought it was time to get rid of it.

A motion was made by Council Member Epps seconded by Council Member Ellis to accept the bid on 1291 South Avenue. All Council Members present voted in favor of this motion.

# **REPORTS FROM STAFF:**

# CONSENT AGENDA:

- (a) Approval and adoption of minutes: August 20, 2013.
- (b) Request for Approving a Resolution Accepting a State Loan with Principal Forgiveness for the Upper Matrimony Creek Sewer Rehabilitation Project.

The City of Eden was officially awarded a Low Interest Loan with Principal Forgiveness by the Clean Water State Revolving Fund (CWSRF) on March 1, 2011, for the East Kuder Street Sewer Rehabilitation project. The State's financial assistance offer is a loan of \$2,718,636.00 at an interest rate of 0.00% per annum. This loan also has principal forgiveness of \$1,000,000 and the project will actually cost the City just \$1,718,636.00 over a term of 20 years.

The Upper Matrimony Creek Outfall Project is designed to improve a large portion failing sewer outfalls bounded by Center Church Street, Oakland Avenue and the Western City Limits ultimately feeding into the Bridge Street Pump Station. The Bridge Street Pump Station then pumps to the Junction Pump Station Basin. We believe that this project will help reduce the sewer system overflows in the Junction Pump Station Basin by reducing the overall flow coming into the Junction Pump Station. The Bridge Street Pump station Basin and the Junction Pump Station Basin are targets of the EPA Administrative order because of the number of sewer overflows we have experienced in the past five years.

By this Resolution the City Council will formally accept the Loan with Principal Forgiveness for \$2,718,636.00. This project is anticipated to be bid about June of 2014. Work on this project is expected to begin by September of 2014.

That City of Eden does hereby accept the State Revolving Loan offer of \$2,718,636.00.

That the City of Eden does hereby give assurance to the North Carolina Department of Environment and Natural Resources that all items specified in the loan offer, Section II -

Assurances will be adhered to.

That Brad Corcoran, City Manager, and successors so titled, is hereby authorized and directed to furnish such information as the appropriate State agency may request in connection with such application or the project; to make the assurances as contained above; and to execute such other documents as may be required in connection with the application.

That City of Eden has substantially complied or will substantially comply with all Federal, State and local laws, rules, regulations, and ordinances applicable to the project and to Federal and State grants and loans pertaining thereto,
